## By entering these premises, you agree to the following terms and conditions of entry (Conditions of Entry):

### 1. Customer Conduct:

Inappropriate behaviour, physical, verbal or otherwise, by customers towards any employee, contractor, member or guest may result in removal from the premises. Regency Park Community Golf Course and SHANX @ Regency Park reserves the right to refuse entry to any person, request any person to leave and / or cancel any season pass in accordance with the terms and conditions. Items that, in the opinion of staff, could cause harm or public nuisance, are not permitted within the facility.

#### 2. Emergency Management:

Please follow signage, direction and requests of Management in the event of an emergency.

### 3. Glass and Weapons:

The use of weapons, glass or other breakable objects should not be brought onto the premises.

#### 4. Responsible Service of Alcohol & Intoxication:

Regency Park Community Golf Course and SHANX @ Regency Park is not licensed to sell alcohol. Under no circumstances whatsoever are facility users to act beyond the responsible consumption of alcohol and must adhere to any and all instruction/s by staff relating to the consumption of alcohol at the facility. Any customer suspected of being under the influence or use of the above will be refused entry and asked to leave.

## 5. Recording devices:

Cameras, mobile phones and electronic recording devices are not permitted within the change rooms. Permission is required to be obtained from staff in the event you wish to capture images within the fitness or other areas prior to taking any photos/videos. By entering you authorise GreenSpace Management and/or City of Port Adelaide Enfield to use all photos taken within the facility to be used for promotional purposes. Should you not wish to be photographed, please advise a staff member prior to entry.

# 6. Smoking:

Regency Park Community Golf Course and SHANX @ Regency Park is a smoke-free venue within all internal areas of buildings. The use of e-cigarettes is also not permitted. Smoking of any kind is not permitted within at least 10m of all buildings, entrances and other internal areas of the facility.

# 7. Your Property:

Personal property should not be left unattended. Regency Park Community Golf Course and SHANX @ Regency Park accepts no liability for any loss or damage to your personal property on the premises.

## 8. Season Pass Holder Conditions:

Season Pass holder conditions apply to all Season Pass holders.

# 9. Facility Etiquette:

Facility etiquette is displayed in prominent locations around the facilities. Customers are required to abide by this etiquette at all times.

## 10. Programs and Services:

Only Employees or Contractors of the Regency Park Community Golf Course and SHANX @ Regency Park can conduct programs or services within the facility.

## 11. Liability:

Despite foreseeable risk and the probability of serious harm, the burden of taking reasonable precautions to avoid the risk of harm lies with the customer. These risks include, but are not limited to, loss or damage to personal property, injury of fatality. The customer acknowledges and agrees that he/she uses the facility at his/her own risk. Also, if the customer suffers injury or illness Regency Park Community Golf Course and SHANX @ Regency Park and /or its employees or agents may arrange medical treatment as deemed essential for the safety of the customer.
