

By entering these premises, you agree to the following terms and conditions of entry (Conditions of Entry):

1. Customer Conduct:

Inappropriate behaviour, physical, verbal or otherwise, by customers towards any employee, contractor, or other customer may result in removal from the premises. Sandy Golf Links reserves the right to refuse entry to any person or equest any person to leave Items that, in the opinion of staff, could cause harm or public nuisance, are not permitted within the facility.

2. Extreme Weather Policy:

The course may be closed due to extreme weather events which includes but not limited to lightening withing 10kms, high wind with gusts exceeding 70kms, flooding, heat. Should the siren sound one blast please evacuate the golf course until advised it is safe to resume play.

3. Course Closure

Should the course close before or during your tee time you may be entitled to compensation by way of a partial or full refund or offer of moving to an alternative day or time at the discretion of Sandy Golf Links mangement.

4. Cancellation Policy:

Should you wish to cancel your golf booking for any reason, you are required to do this online for a full refund. Cancellations made with less than 24 hours will not be entitled to a refund. To cancel your booking head to www.sandy.golf - book - book a teetime - log in with your email and password and scroll the the bottom of the page where you will see your reservations.

5. Tee Time Management:

Sandy Golf Links reserves the right to move you booking by one tee time (usually 8 or 9 minutes). This can be for any reason to manage the tee sheet on any day. Should any other changes be required we will contact you.

6. Emergency Management:

Please follow signage, direction and requests of Management in the event of an emergency.

7. Weapons:

Weapons of any kind must not be brought onto the premises.

8. Responsible Service of Alcohol & Intoxication:

Sandy Golf Links is licensed to sell alcohol. No alcoholic beverages are to be consumed on the premises that have not been purchased from the point of sale (cafe, kiosk, mobile drinks cart). Liquor purchased from other outlets, such as a bottle shop, must not be consumed on our entire property. Under no circumstances whatsoever are facility users to act beyond the responsible consumption of alcohol and must adhere to any and all instruction/s by staff relating to the consumption of alcohol at the facility. Any action beyond this instruction and condition of entry will result in patrons being asked to leave the premises.

9. Recording devices:

Cameras, mobile phones and electronic recording devices are not permitted to be used within the change rooms. By entering you authorise Sandy Golf Links to use

all photos taken within the facility to be used for promotional purposes. Should you not wish to be photographed, please advise a staff member prior to entry.

10. Smoking:

Sandy Golf Links is a smoke-free venue within all internal areas of buildings. The use of e-cigarettes is also not permitted. Smoking of any kind is not permitted within at least 10m of all buildings, entrances and other internal areas of the facility.

11. Payments

Sandy Golf Links accepts payment by electronic transactions only. Cash is no longer accepted at the facility.

12. Your Property:

Personal property should not be left unattended. Sandy Golf Links accepts no liability for any loss or damage to your personal property on the premises. Parking is at his/her own risk and Sandy Golf Links accepts no liability for damage to or loss of any vehicle or its contents.

13. Damage Caused by you:

You accept responsibility for any damage caused by you or any member of your party and that you will be liable for any expense incurred as a result of such damage and you agree to report any damage caused by you or your party to property or other persons both on and outside the course boundary to the Senior staff on duty.

14. Programs and Services:

Only Employees or Registered Contractors of either Sandy Golf Links, Golf Australia, or the onsite Professional Golf Association of Australia can conduct programs or services within the facility.

15. Liability:

Despite foreseeable risk and the probability of serious harm, the burden of taking reasonable precautions to avoid the risk of harm lies with the customer. These risks include, but are not limited to, loss or damage to personal property, injury of fatality. The customer acknowledges and agrees that he/she uses the facility and car parking at his/her own risk. Also, if the customer suffers injury or illness Sandy Golf Links and /or its employees or agents may arrange medical treatment as deemed essential for the safety of the customer.

Failure to comply with any of these Conditions of Entry may result in you being refused entry to or evicted from the premises and future re-entry refused.
